



## Sunalta Toy Lending Library Agreement

Between

Sunalta Community Association Toy Lending Library

The Sunalta Community Association (SCA) Toy Lending Library is collecting the above personal information for the sole purpose of maintaining their lending library.

For the purposes of this agreement, all items available (toys, costumes, books, activity bags, audio-visual materials, and other resources) will be referred to as “resources”.

This is rental contract only. The Sunalta Community Association Toy Lending Library (SCA) retains full and complete ownership of any product or item(s) being used by the undersigned.

1. I hereby agree that I and/or my family will be the sole users of the borrowed item(s). I agree to release, save harmless, and indemnify the SCA and/or its agents from and against all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to person or property, arising out of, or in connection to the borrowing of resources/toys/equipment from the SCA.
2. Upon borrowing a resource, I understand that it is the responsibility of myself to ensure all pieces are present. If there are discrepancies, I will notify the SCA within 48 hours.

3. I agree to use resources appropriate to the children's ages and only under the supervision of an adult. I agree to periodically inspect items for damage. If damage is found, I will return it to the SCA immediately and communicate the damage.
4. I agree that upon receiving resources in good, clean, useable condition, I will return them in the same good, clean, useable condition. I further agree to remit a \$10.00 fee to the SCA should any items be returned in unsatisfactory condition.
5. I agree that I am responsible for the cost of any resources I have lost or damaged. The replacement fee will be determined by the SCA and will be based on the item's initial cost, age, and condition. Replacement fees are due within 30 DAYS of receipt of an invoice from the SCA. I understand that in the event that I have any outstanding fees, my lending privileges will be suspended until my fees are paid in full.
6. I agree to return all resources by the due date. The due date will be one week after an item is borrowed (unless otherwise stated).
7. I understand that it is my responsibility to notify the SCA in the event that there are any changes to the family members that are authorized to pick up resources on my behalf.
